# Invest in Your Landscape



## About the Program

Transforming your commercial property's turf grass to California Friendly® sustainable landscaping is an investment that can save you money and water long-term. Recent state legislation will prohibit watering non-functional grass with potable drinking water on non-residential properties, starting in 2027. To help achieve this goal, Metropolitan's Commercial Turf Replacement Program offers rebates starting at \$2 per square foot of grass replaced for businesses and industrial properties. Your local water agency may offer additional incentives for this program.



### What is Non-Functional Turf?

Non-functional turf is grass that is not used for recreational or community purposes. Examples include highway/street medians, turf surrounding office buildings and turf on sloped areas.

## Application Process

### Step 1: Reserve Your Rebate

The first step is to reserve your rebate **BEFORE** starting your project or removing any grass. Use the [Estimate Your Rebate](#) tool available via [bewaterwise.com](#) to get an estimated rebate amount.

### Step 2: Start Your Project

Once the reservation is approved, you have 180 days to complete your commercial landscape project. To receive your reserved rebate, you must meet all project requirements.

### Step 3: Claim Your Rebate

After completing your project, return to your application to submit a request for your rebate.

## Rebate Eligibility

- There is a limit of one application per water meter per year.
- The project must have a minimum of 250 square feet of turf removed in the project area. All turf must be removed if the entire project area is less than 250 square feet.
- A maximum of 50,000 square feet of turf per application is eligible for funding each fiscal year.
- The project cannot be started or completed prior to applying for the rebate. Areas that have already had turf removed are ineligible.
- Proposed projects irrigated with recycled water are eligible unless exempted by the Metropolitan member agency.
- Artificial or synthetic turf is not allowed.



## Project Requirements

- ✓ Three California Friendly® plants per 100 square feet of grass transformed.
- ✓ A stormwater retention feature to help keep water in your landscape when it rains. Rain or rock gardens, swales and rain barrels/cisterns are examples.
- ✓ Only permeable hardscapes such as mulch and decomposed granite are permitted. This allows water to flow through the surface and slowly filter into the ground.
- ✓ A replacement or modification of overhead spray sprinklers to a more water-efficient irrigation system is required for all projects.

## Add Trees to Your Landscape

**Coming soon.** Beginning in early 2024, the Turf Replacement Program will include an additional incentive for eligible trees incorporated into your commercial site's landscape design. Get \$100 per tree planted for a maximum of five trees. A list of eligible trees will be available.

- The minimum size for each tree is 15 gallons.
- Edible fruit trees are **not allowed** on commercial properties.

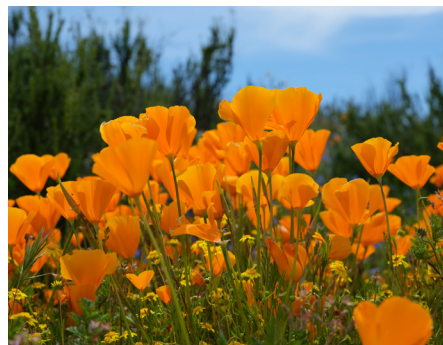
